KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of **Three Hundred Ten Thousand and No/100 (\$310,000.00)**, and other good and valuable consideration, this day in hand paid to the undersigned **Julianne Christine Sparkman n/k/a Julianne Christine Kinnebrew and husband, Jacob Robert Kinnebrew** (hereinafter referred to as GRANTORS), in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **James Richard Brandt and Maria Gallian Brandt** (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:
