LEGAL DESCRIPTION

HILLSBORO SOUTH SUBDIVISION

Tract of land situated in the East ¼ of the Northwest ¼ and the East ½ of the Southwest ¼ in Section 28, Township 20 South, Range 3 West, Shelby County, Alabama, and being more particularly described as follows.

BEGIN at the Northeast corner of the Southwest ¼ of said Section; thence run South along the East line of said ¼ section a distance of 2652.5 feet, more or less, to the Southeast corner of said ¼ section and also a point on the South line of said Section; thence turn an angle of 91° 00' 00" to the right in a Westerly direction along the South line of said Section a distance of 1323 feet, more or less, to the Southwest corner of the Southeast ¼ of the Southwest ¼ of said Section; then turn an angle of 90° 00' 00" to the right in a Northerly direction along the West line of the Southeast ¼ of the Southwest ¼ and the West line of the Northeast ¼ of the Southwest ¼ of said Section a distance of 1627.0 feet; thence turn an angle of 17° 30' 00" to the right in a Northeasterly direction a distance of 935.5 feet; thence turn an angle of 16° 30' 00" to the right in a Northeasterly direction a distance of 213.6 feet; thence turn an angle of 40° 00' 00" to the right in a Northeasterly direction a distance of 320.0 feet; thence turn an angle of 42° 30' 00" to the left in a Northeasterly direction a distance of 100.0 feet; thence turn an angle of 38° 00' 00" to the left in a Northwesterly direction a distance of 539.0 feet; thence turn an angle of 77° 30' 00" to the left in a Westerly direction a distance 128.1 feet; thence turn an angle of 45° 15' 00" to the left in a Northwesterly direction a distance 319.3 feet; thence turn an angle of 66° 00' 00" to the right in a Northeasterly direction a distance of 417.0 feet; thence turn an angle of 58° 00' 00" to the right in a Easterly direction a distance of 372.2 feet, more or less, to the center line of a public road (Hillsboro Parkway); thence right 40° 00' 00", more or less, in a Southeasterly direction along the center line of said road a distance 223.7 feet; thence leaving said road turn an angle of 75° 00' 00" to the right in a Southwesterly direction a distance of 177.0 feet; thence turn an angle of 10° 00' 00" to the left in a Southerly direction a distance of 203.0 feet; then turn an angle of 10° 00' 00" to the left in a Southerly direction a distance of 158.6 feet; thence turn an angle of 93° 00' 00" to the left in a Easterly direction a distance of 170.0 feet; thence right in a Southeasterly direction along a straight line to the **POINT OF BEGINNING**.
