**WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP**

**KNOW ALL MEN BY THESE PRESENTS,**

**On this February 23, 2026**, That for and in consideration of **TEN AND NO/100 (\$10.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **GRANTORS TRINITY CORNETT and JEREMY CORNETT, husband and wife**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the GRANTEE, **TRINITY CORNETT and JEREMY CORNETT**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 24, according to the Amended Map of Savannah Pointe Sector IX, as recorded in Map Book 37, Page 51 A & B, in the Probate Office of Shelby County, Alabama.

Subject to:


1. General and special taxes or assessments for the year 2026 and subsequent years not yet due and payable.



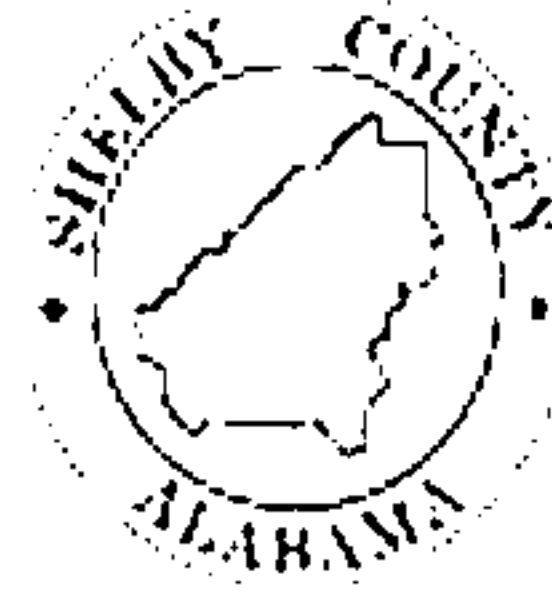
