**GENERAL WARRANTY DEED

Rohrbach and Cynthia F. Rohrbach, husband and wife** (hereinafter referred to as "Grantors"), whose address is 6005 Hopewell Rd SE, Bessemer, AL 35022, the receipt and sufficiency of which is hereby acknowledged, by **Ashley Antin and Kenneth Antin** (hereinafter referred to as "Grantees"), whose address is 8028 Rockhampton Cir., Helena, AL 35080, hereby grant, bargain, sell and convey unto Grantees, as joint tenants with right of survivorship, in fee simple absolute together with every contingent remainder and right of reversion, and subject to all the provisions contained in this warranty deed, the following described real property situated in Shelby County, Alabama, to-wit:

\$318,250.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herein.




