GENERAL WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of SEVEN HUNDRED SIXTY EIGHT THOUSAND AND 00/100 (\$768,000.00), and other good and valuable consideration in hand paid to Michael Earl Turner and Cheryl Ann Turner, Trustees of The Michael Earl Turner and Cheryl Ann Turner Revocable Living Family Trust dated November 8, 2023 (hereinafter referred to as "Grantor(s)"), the receipt and sufficiency of which is hereby acknowledged, by the Renee S. Genereux and Anthony A. Smith, wife and husband (hereinafter referred to as "Grantee(s)"), Grantor(s) hereby GRANT(S), BARGAIN(S), SELL(S) and CONVEY(S) unto Grantee(s), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.


\$614,400.00 of the above consideration was secured by and through a purchase money mortgage closed and recorded herewith.
