Galafassi, wife and husband** (hereinafter referred to as "Grantors"), whose address is 5189 Simms Ridge, Pelham, AL 35124, the receipt and sufficiency of which is hereby acknowledged, by **Ryan Kelley McNamara and Jennifer McNamara** (hereinafter referred to as "Grantees"), whose address is 2102 S. 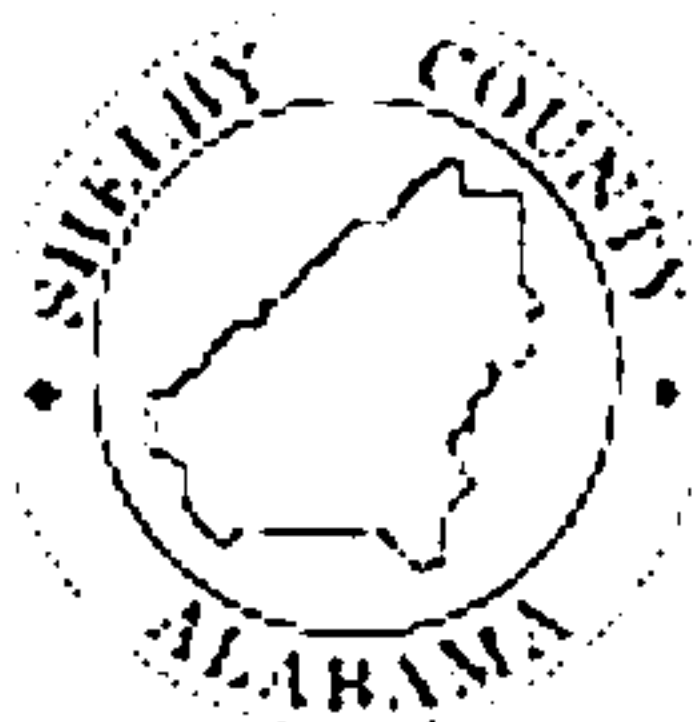
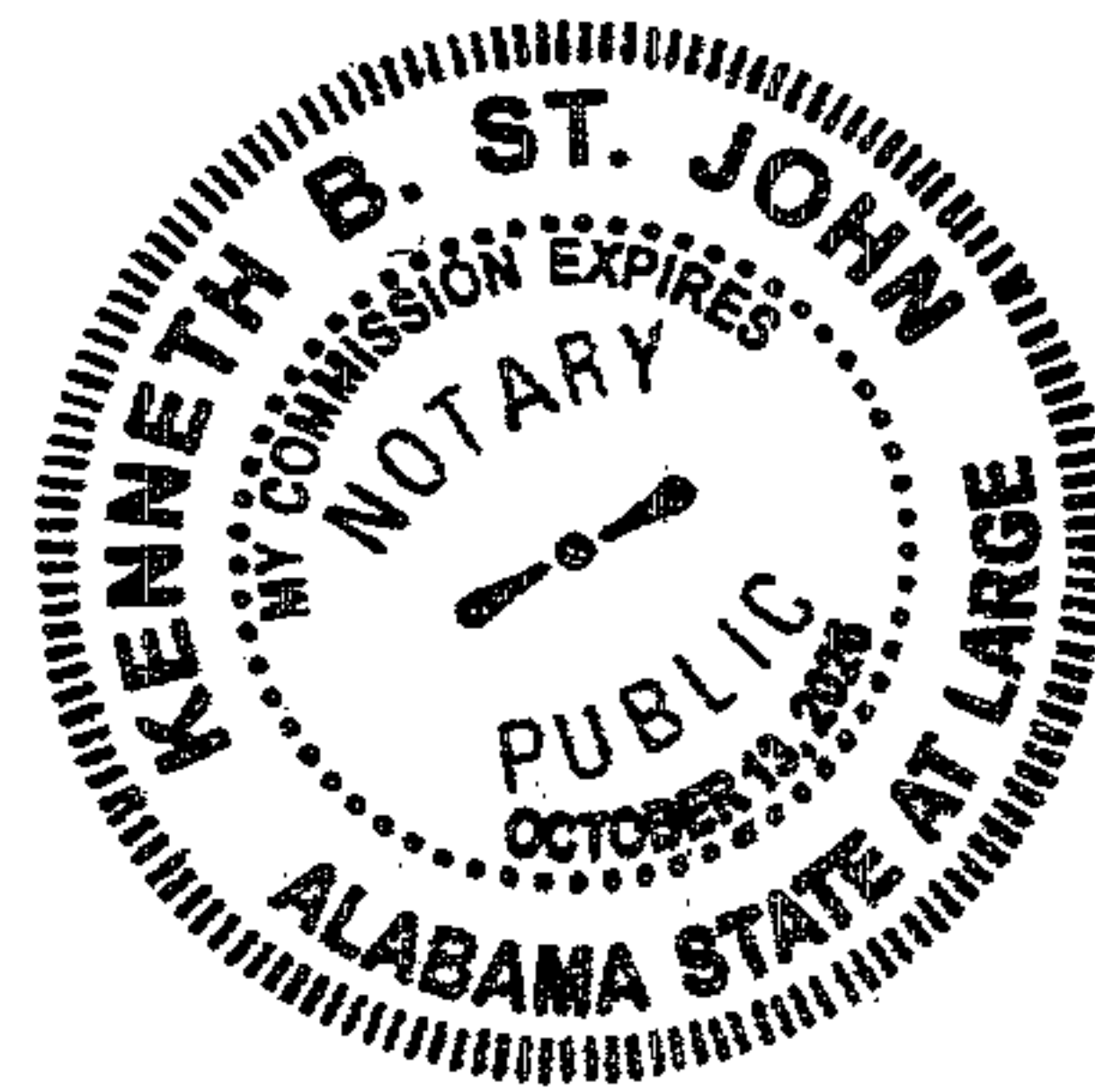
