



**CERTIFICATION OF TRUST OF



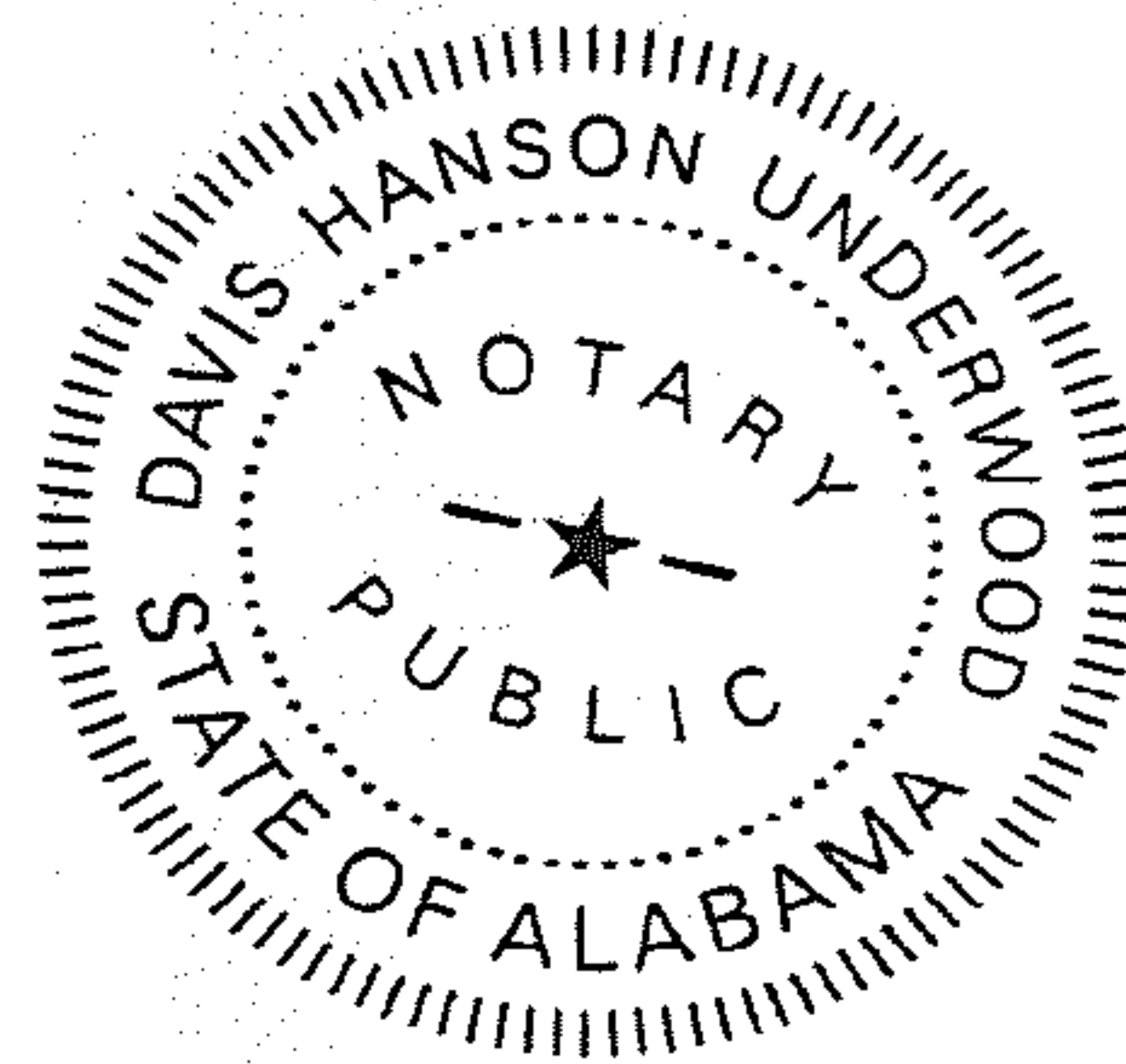


