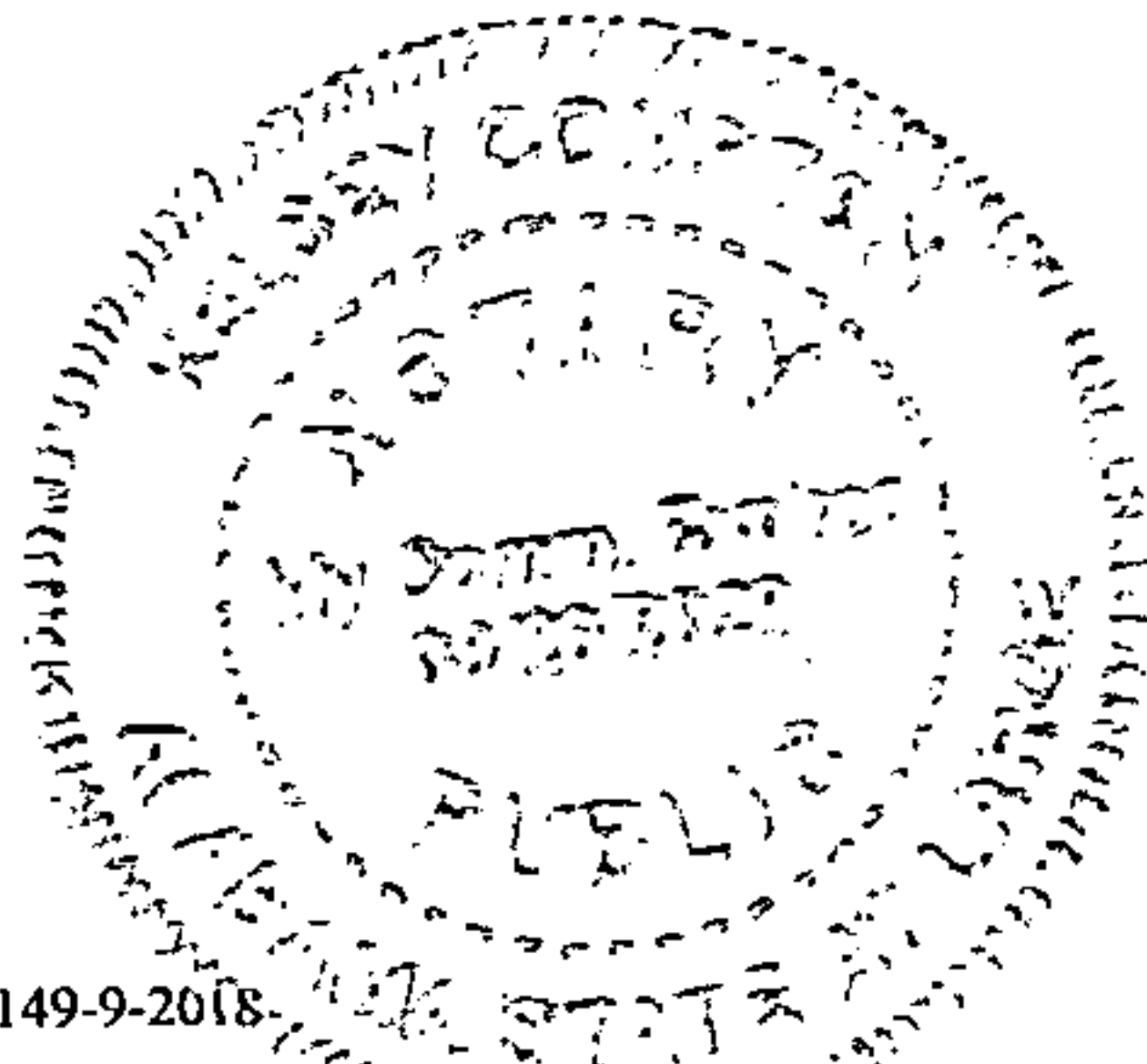

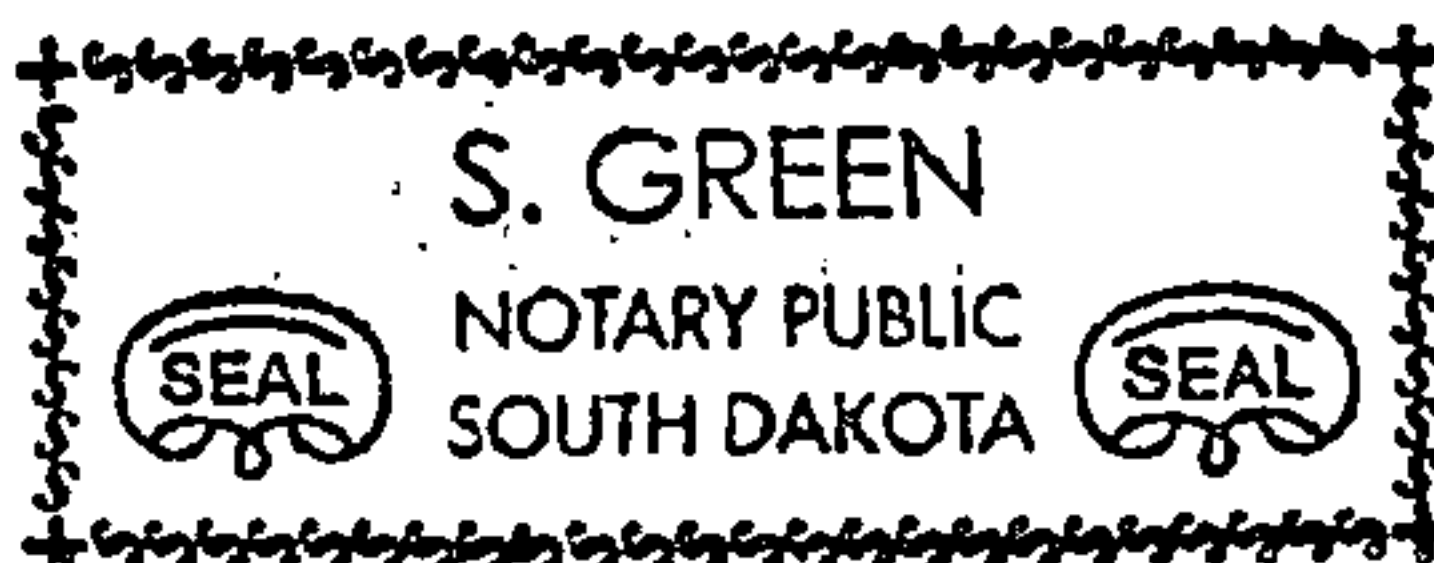


1. To administer oaths; and

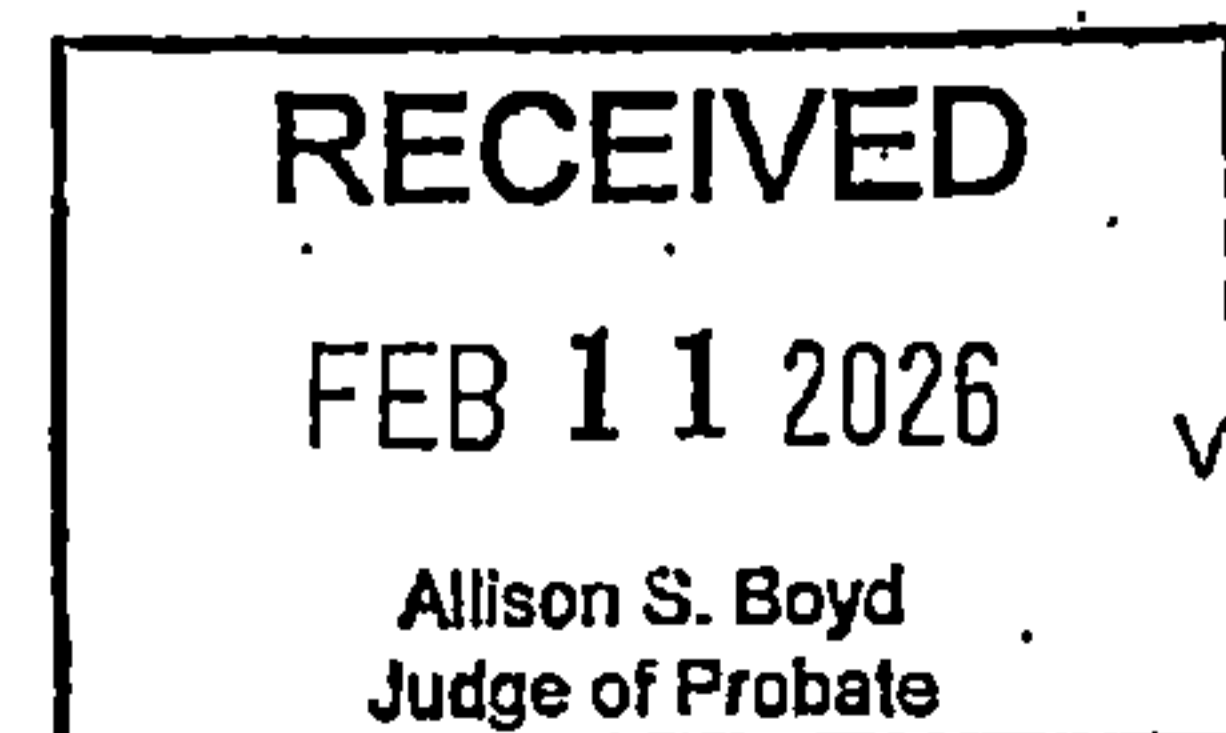
