**GENERAL WARRANTY DEED**  
**With Right of Survivorship**

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of SIX HUNDRED ELEVEN THOUSAND FIVE HUNDRED AND 00/100 (\$611,500.00), and other good and valuable consideration in hand paid to Kyle R. McMullen and Allison N. McMullen, a married couple (hereinafter referred to as "Grantor(s)"), the receipt and sufficiency of which is hereby acknowledged, by the Stephen Waters and Kimberly Waters, a married couple (hereinafter referred to as "Grantee(s)"), Grantor(s) hereby GRANT(S), BARGAIN(S), SELL(S) and CONVEY(S) unto Grantee(s), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

**Lot 1823, according to the Survey of Blackridge South Phase 8, as recorded in Map Book 58, Page 10, in the Probate Office of Shelby County, Alabama.**

Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.

\$220,000.00 of the above consideration was secured by and through a purchase money mortgage closed and recorded herewith.

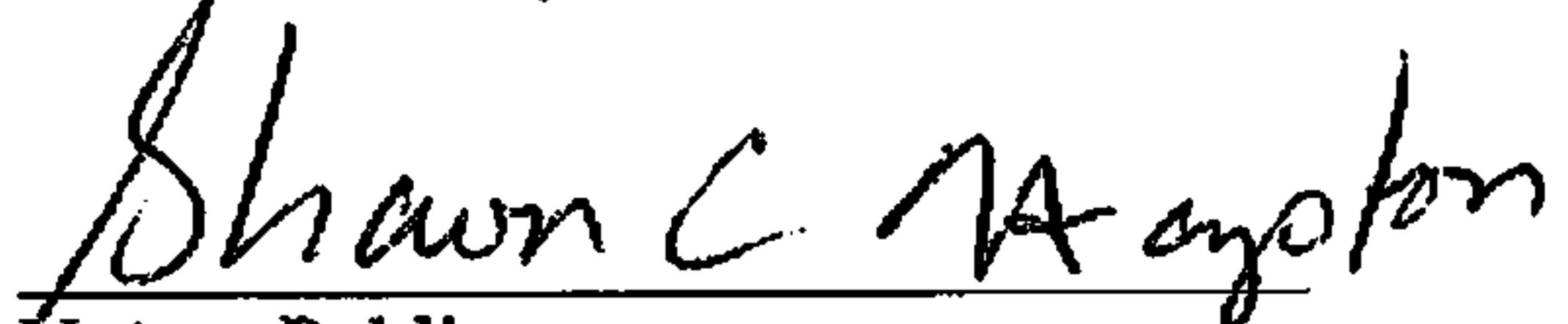

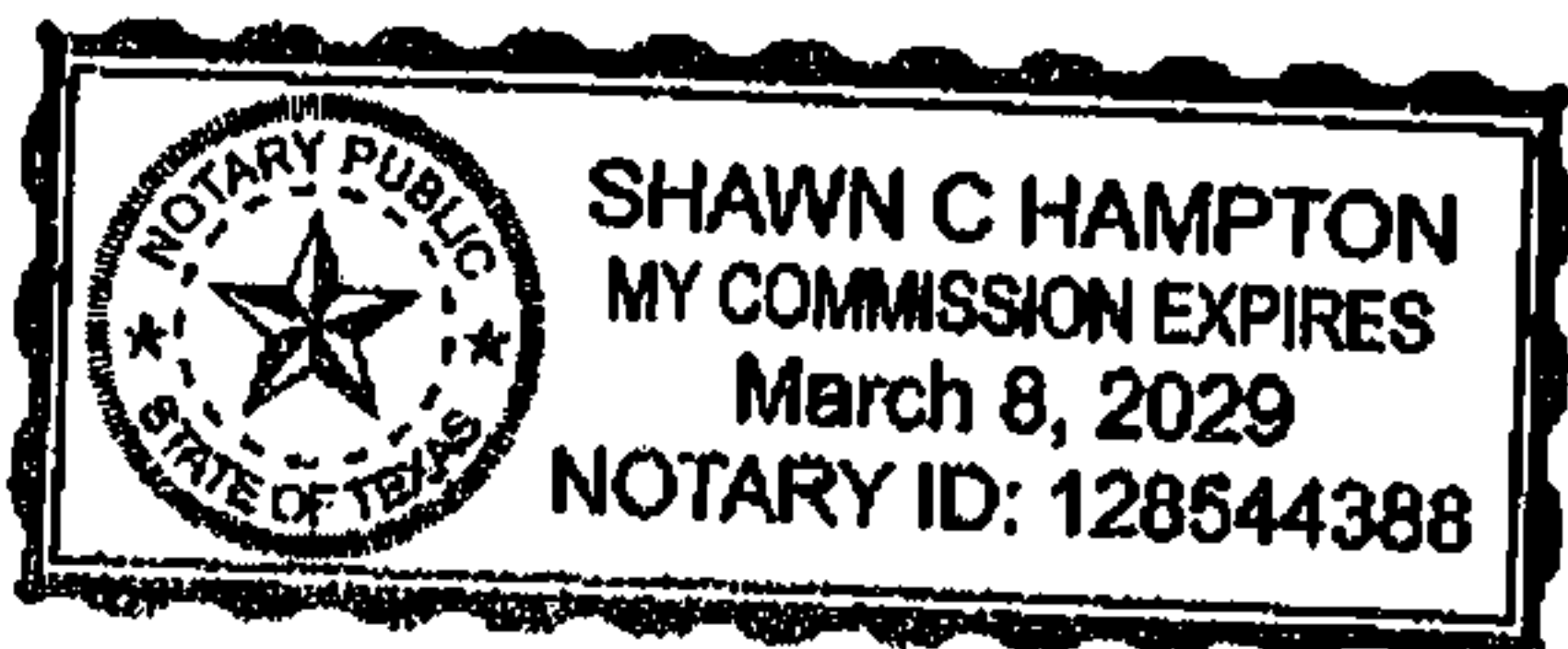

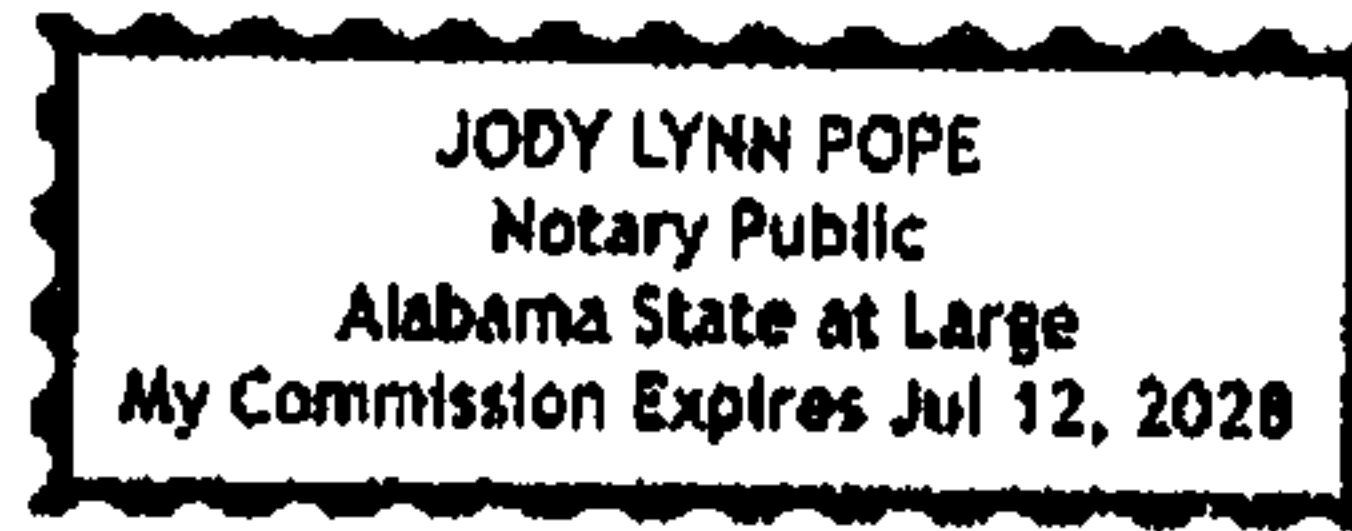
