**\$316,000.00** of the above-recited purchase price was paid from a mortgage loan closed simultaneously herein.





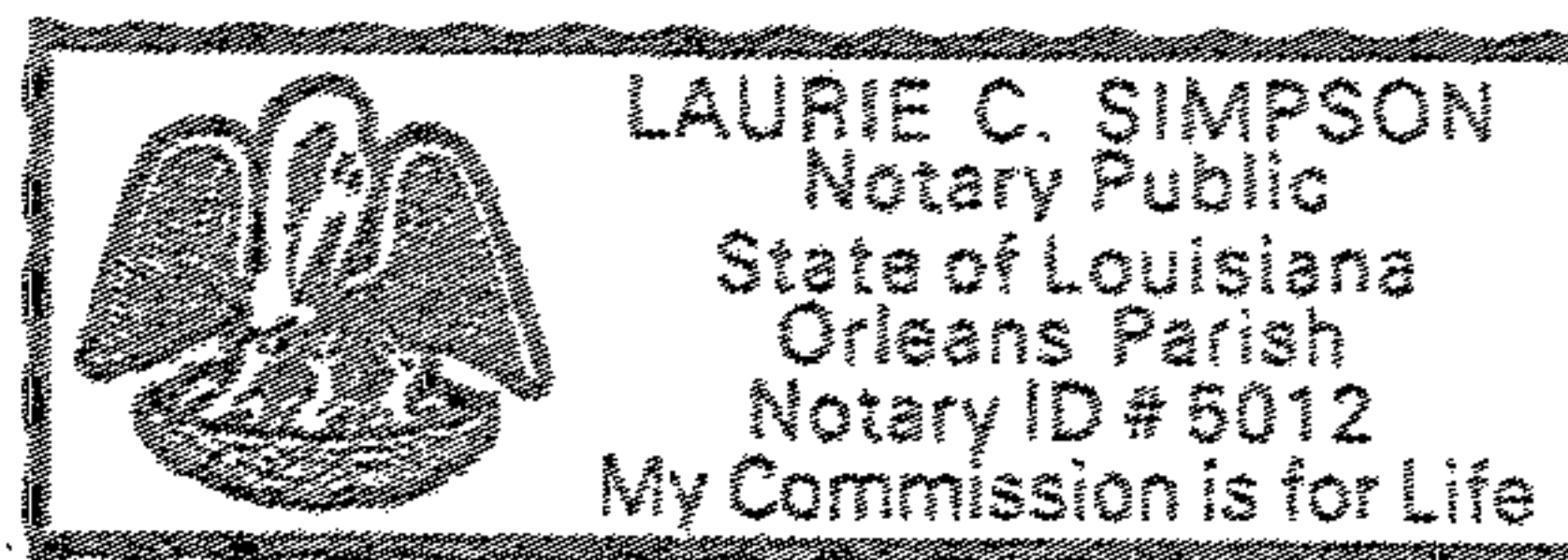
