AFFIDAVIT OF HEIRSHIP

Before me, the undersigned authority, a Notary Public, in and for the State of Alabama, personally appeared **Mackey McNeal**, who is personally known to me and/or did confirm her identity presenting valid identification, and appearing to be fully competent and of sufficient age, upon being duly sworn, states upon Affiant's oath the following:

1. My name is Mackey McNeal, and I am over the age of nineteen (19) years and a bona fide resident of the State of Alabama. My address is 121 4th Place SE, Alabaster, Alabama, 35007. I am personally familiar with the family and marital history of Clifton Taylor, Jr. deceased (hereinafter, the "Decedent"), who was my neighbor for over 50 years, and I have personal knowledge of the facts stated in this Affidavit.

2. I knew the Decedent until he passed away on February 3, 2019. At the time of his death, he was married to Mattie Taylor. Their residence was located at 126 4th Place SE, Alabaster, Alabama 35007.

3. From information and belief, the Decedent did not leave a Last Will and Testament and died intestate.

4. The Decedent's estate was never administered in any probate court.

5. The Decedent left a surviving spouse and five children, whose names are: Clifton Taylor, III, Tammy Taylor Williams, Nellie Nelson, Veronica Lynette Taylor Swift, and Sheron Diane Taylor.

a. The Decedent's daughter, Sheron Diane Taylor, predeceased him on June 26, 2012, leaving four children, whose names are: Corey Lamont Hall, Cynthia Yavette Johnson, Carlos Hobert Hall, Jr., and Madilyn Hall Demoss. From information and belief, Sheron Diane Taylor died intestate, and her estate was never administered.

i. The Decedent's Granddaughter, Madilyn Hall Demoss, predeceased him on August 30, 2017, leaving three children, whose names are: Christopher Allen Demoss, Jr., Christin Danielle Demoss, Sharyn Deanne Williams. From information and belief, Madilyn Hall Demoss died intestate, and her estate was never administered.

b. The Decedent's daughter, Veronica Lynette Taylor Swift, predeceased him on March 1, 2017, leaving no surviving spouse and no children. From information and belief, Veronica Lynette Taylor Swift died intestate, and her estate was never administered.

6. The Decedent's spouse, Mattie Taylor died on April 13, 2025, in Shelby County, Alabama. As of the date of this Affidavit, her estate is being administered through the Shelby County Probate Court (Case Number: PR-2025-002768).



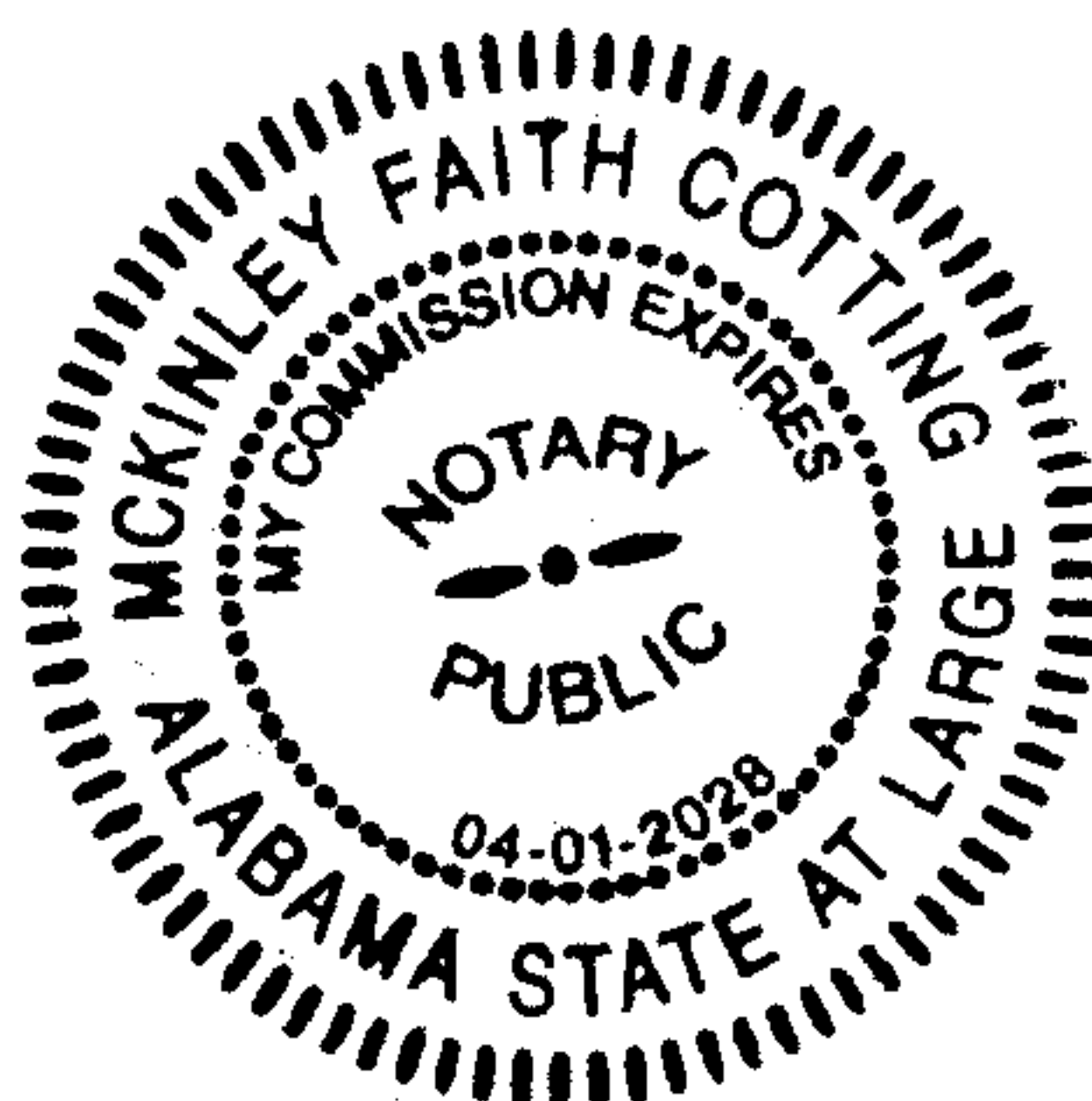
