KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, July 29, 2010, Janice E. Craig, unmarried woman, executed that certain mortgage on real property hereinafter described to Wells Fargo Bank, N.A., which said mortgage was recorded in Instrument Number 20100823000270330 in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage subsequently transferred and assigned to GITSIT Solutions, LLC, not in its individual capacity but solely in its capacity as Separate Trustee of GV Trust 2026-1 by instrument recorded in Instrument Number 20260209000037160 in the aforesaid Probate Office (hereafter "Transferee"); and

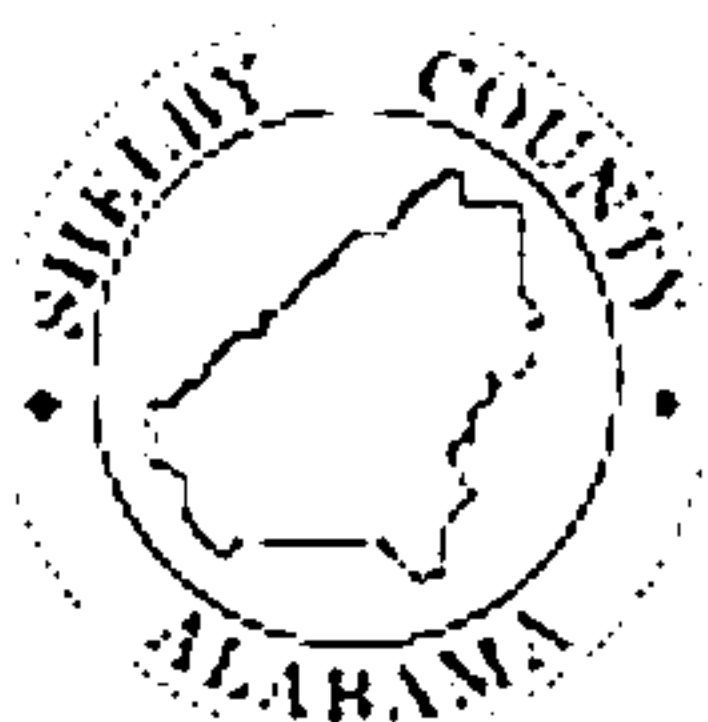
