WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS,

On this March 16, 2026, That for and in consideration of **TEN AND NO/100 (\$10.00)** **DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS **JOHN WILLIAM HANSON and MARGARET MCCORMICK HANSON, husband and wife, and LEE B. MCCORMICK, an unmarried man**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the GRANTEES, **JOHN WILLIAM HANSON and MARGARET MCCORMICK HANSON**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.

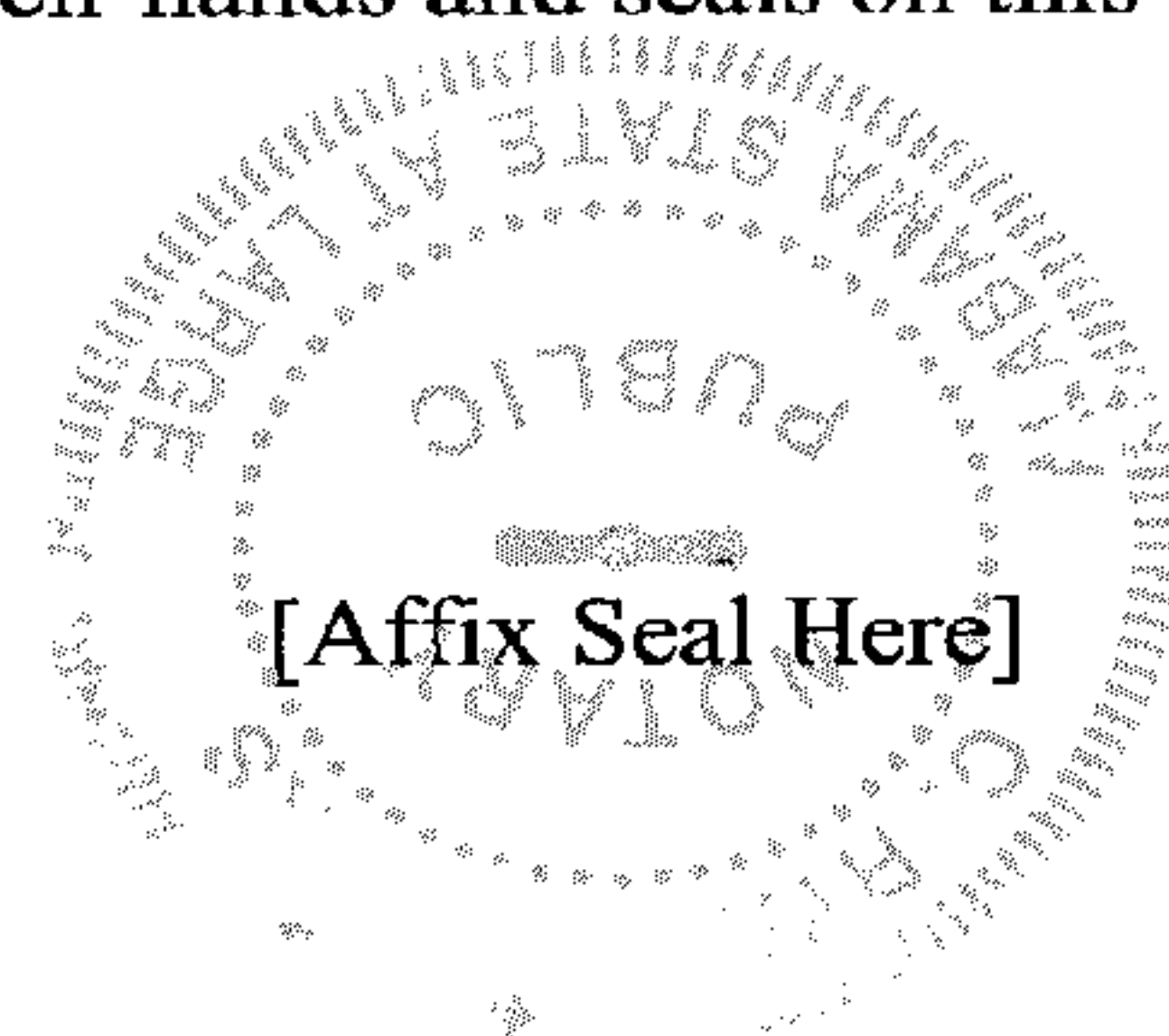

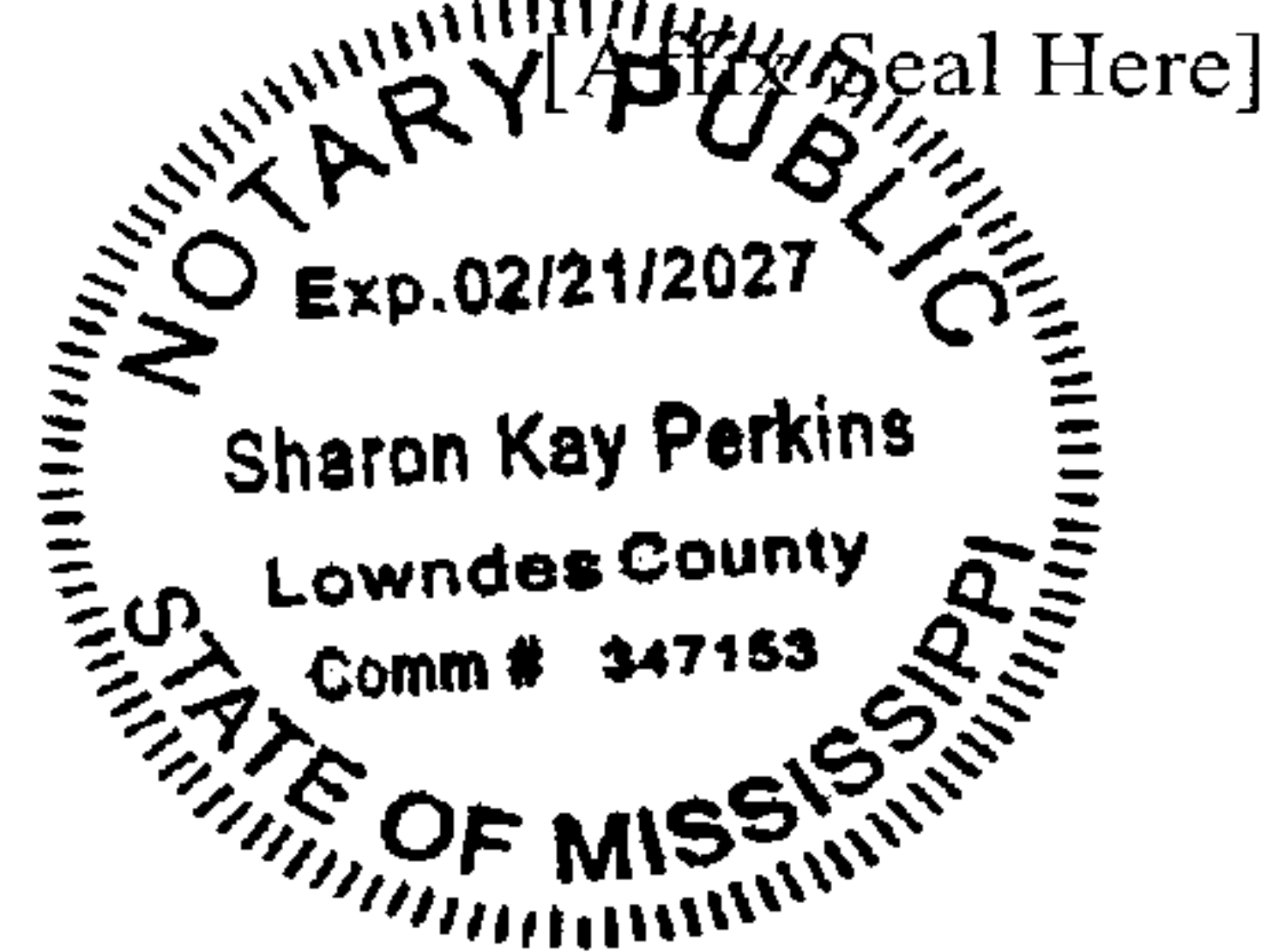
