LIFE ESTATE DEED

Talmadge, husband and wife** (hereinafter referred to as GRANTOR whether one or more), the receipt whereof is hereby acknowledged, it is the intention of the GRANTOR to reserve to himself/herself/themselves during the full term of his/her/their natural life(lives) the right of possession and occupancy in and to the real estate and the rents and profits arising from it, and to convey unto the GRANTEE, **Steven L. Talmadge and Tracie Ann Talmadge** (hereinafter referred to as GRANTEE whether one or more), the full fee simple title to the real estate, subject only to a life estate reserved herein by GRANTOR, legally described as:

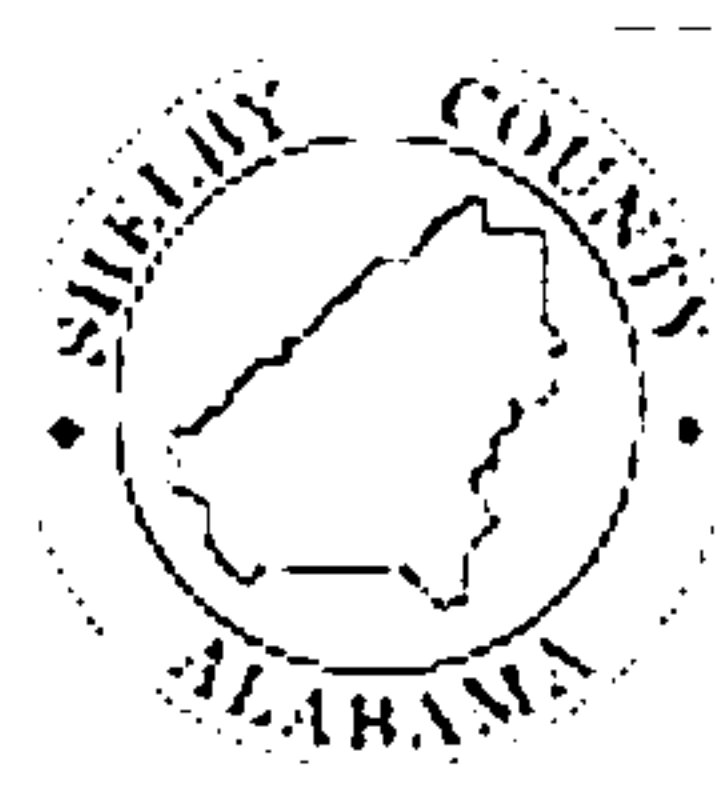
