**D.R. Horton, Inc. – Birmingham** (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

**Karen Lisbeth Rodriguez Benitez** (herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in **Shelby County, Alabama**, to-wit:



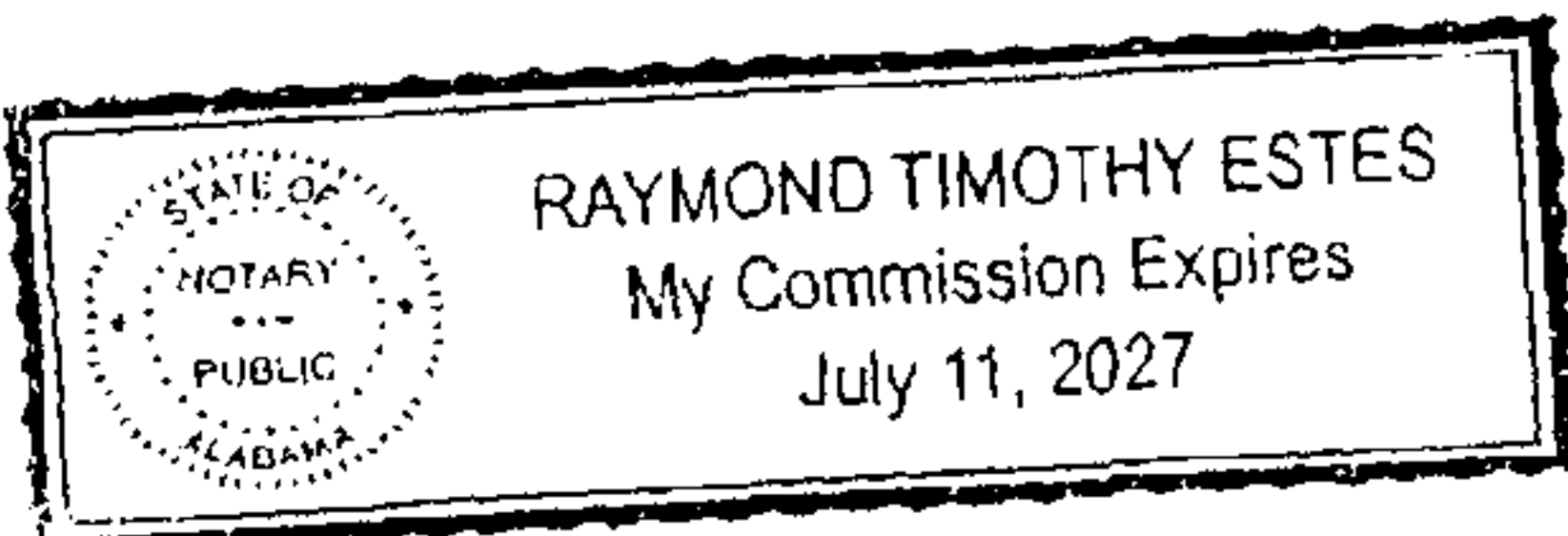
