I, Mary H. Harris, Clerk of the Circuit Court of Shelby County, Alabama, hereby certify that on December 17, 2025, the Circuit Court of Shelby County, Alabama, entered an Amended Order Granting Summary Judgment in the above-styled action (58-CV-2024-900883.00, Doc. 231).

The style of the case is BUILDPOINT, LLC v. INVERNESS OFFICE PARK AL, LLC ET AL, and the names of all parties thereto are set forth on the attached party listing, which is incorporated herein by reference. For purposes of this judgment, Co-Plaintiff C002 – INFINITY FIRE PROTECTION, LLC is the judgment creditor, and Defendant D002 – REGIONAL BUILDERS, INC. is the judgment debtor.

Judgment was entered in favor of C002 – INFINITY FIRE PROTECTION, LLC and against D002 – REGIONAL BUILDERS, INC. in the amount of \$24,790.02, which includes prejudgment interest, without waiver of exemptions. Court costs in the amount of \$506.96 were taxed against D002 – REGIONAL BUILDERS, INC., for a total judgment and costs of \$25,296.98.

The Court expressly determined that the Amended Order (Doc. 231) constitutes a final judgment pursuant to Rule 54(b) of the *Alabama Rules of Civil Procedure* as to the claims of C002 – INFINITY FIRE PROTECTION, LLC against D002 – REGIONAL BUILDERS, INC.


Post-judgment interest shall accrue on the judgment pursuant to Ala. Code § 8-8-10 until paid in full.
